Welcome to our tennis club, we look forward to you joining us for a game of tennis in the near future. At East Wavertree we support junior tennis players with special events and coaching.

East Wavertree Tennis Club is part of East Wavertree & Childwall Community Association (EWCCA) which is a registered charity and we operate a Gift Aid scheme which allows us to reclaim 25% of subscriptions (donations) if member's parents or the payer of the subscriptions are UK tax payers.

In order to claim the Gift Aid on subscriptions we encourage members to pay them as a single payment donation to EWCCA (the registered charity). For this process we need to have an audit trail and would ask member's parents or subscription payer to complete and sign the Gift Aid form enclosed with their application.

Junior players **must wear membership tags on their tennis shoes on every visit to the club**. Junior players not wearing their tags in this manner will be asked to leave the court. Tags will be sent by post on receipt of all forms and due payment.

Your parent is asked to complete the application, overleaf. This must be returned with a signed proforma confirming that you and your parent agree with the contents of the documents "code of practice for young people" and "code of practice for parents/guardians" and the contact and medical form. Membership will not be confirmed without these documents
